GIVEN

- ND Constitution/Morality/1889/Webster 1828/WLC 10
- Broad agreement on current culture/Biblical views in COR 17 worldview documents & Summit Worldview Chart
- Goal is to give glory to and acknowledge God in legislative bills, which results in His blessing on ND people.
- Knowing the value of an historical view of current affairs (ref. CS Lewis).
- Remember violation of one command is violation of all (James 2:10).
- Knowledge that civil government only has legitimate authority where seen in Scripture. Not every sin requires civil government action, only where Scripture requires civil government action (e.g., death penalty).

FIND:

- A reasonable system to score ND legislative bills on its conformity to God's Word as summarized in the 10 Commandments.
- Check each bill point against each commandment.,
- Score +1 for each conforming, -1 for each non-conforming.
- Possible score -100 to +100

SOLUTION

PROCEDURE

- 1. Reader Review:
 - a. Identify bill aims, funding, regulations.
 - b. Flag moral 10 C concerns.
- 2. Theological Review:
 - a. Provides 10 C based review using WLC, COR 17, Summit Chart.
 - b. Assigns preliminary score
- 3. Al Assistant
 - a. Identifies keywords, concepts, phrases that may violate or support 10C using WLC scripture references, COR 17 and Summit Chart.
 - b. Highlights potential consequences, study areas, additional related scripture.
 - c. Assigns preliminary score.
- 4. Scoring Committee
 - a. Review human and AI preliminary scores to finalize score.
 - b. Addresses ambiguities & discrepancies.

Benefits

- Moves legislature toward aligning with Biblical principles and ND Constitutions morality.
- Accountability for lawmakers.
- Solid historical standard of measure with modern context.
- Structured, transparent approach to moral evaluation.
- Feedback loop to improve process of evaluation.

Challenges

- Educating people in how to practically apply the 10 commandments as it was done in early America.
- Educating people in the aspects of the anti-Christian worldviews operating today so they can see the contract with the 10C.

Scoring rubric

Negative Scoring (Violations)

- **Clear Scriptural Violation:** -1 point per instance (e.g., explicit funding for unbiblical purposes).
- **General Equity Breach:** -1 point for indirect or broader violations of principles (e.g., promoting ideologies contrary to biblical teaching).

Positive Scoring (Affirmations)

- **Clear Scriptural Adherence:** +1 point per instance (e.g., protecting life, property rights).
- **General Equity Affirmation:** +1 point for indirect adherence to biblical principles.

Zero Scoring

• Neutral provisions or those not clearly addressed in Scripture.

Examples:

- First Commandment (No Other Gods):
 - Negative: Funding secular indoctrination (-10).
 - Positive: Protecting religious freedom (+10).
- Eighth Commandment (No Stealing):
 - Negative: Unjust taxation or redistribution (-5 to -10).
 - Positive: Tax incentives for charitable giving (+5).

Example

HB 1001

Using the Westminster Larger Catechism method, here is the evaluation of House Bill No. 1001, which appropriates funds for the expenses of the Office of the Governor of North Dakota:

Bill Overview

- **Purpose**: To allocate \$5,266,996 from the general fund for salaries, operations, contingencies, and awards in the Governor's Office for the biennium of July 1, 2025, to June 30, 2027.
- Key Provisions:
 - Salary and wages: \$4,426,244.
 - Governor's salary: \$310,621.
 - Operating expenses: \$509,331.
 - Contingencies: \$10,000.
 - Rough Rider Awards: \$10,800.
 - Full-time equivalent positions: 19.

Evaluation Using the Ten Commandments

1. First Commandment: No Other Gods

- **Positive**: No explicit promotion of idolatry or secular ideologies.
- **Negative**: The general lack of acknowledgment of God's sovereignty over government operations could be seen as an implicit rejection of biblical governance principles.
- **Score**: -1.

2. Second Commandment: No Idolatry

- **Positive**: The bill does not allocate funds for idolatrous purposes or symbols.
- **Negative**: None identified.
- **Score**: +0.

3. Third Commandment: Honor God's Name

- **Positive**: The bill does not misuse God's name or principles.
- Negative: Absence of acknowledgment of God's authority in the operations of the governor's office.
- **Score**: -1.

4. Fourth Commandment: Remember the Sabbath

- **Positive**: No provisions requiring Sabbath violations.
- **Negative**: None identified.
- **Score**: +0.

5. Fifth Commandment: Honor Authority

- **Positive**: The bill provides for the legitimate functioning of civil authority, which aligns with biblical teaching on honoring those in authority (Romans 13:1-7).
- Negative: Allocation of significant funds without direct accountability to biblical principles.
- **Score**: +1-1=0.

6. Sixth Commandment: Do Not Murder

- Positive: No evidence of funds supporting actions that undermine the sanctity of life.
- **Negative**: None identified.
- **Score**: +0.

7. Seventh Commandment: Do Not Commit Adultery

- **Positive**: No provisions promoting immorality.
- Negative: None identified.
- **Score**: +0.

8. Eighth Commandment: Do Not Steal

- Positive: Funds appear allocated for legitimate governmental operations.
- Negative: Potential misuse of funds or excessive taxation to sustain this budget may indirectly violate property rights.
- Score: +1-1=0.

9. Ninth Commandment: Do Not Bear False Witness

- **Positive**: Requires reporting and transparency about additional income and its usage.
- **Negative**: None identified.
- **Score**: +2.

10. Tenth Commandment: Do Not Covet

- **Positive**: No evidence of promoting envy or covetousness.
- **Negative**: None identified.
- **Score**: +0.

Recommendation on HB 1001

Recommendation

The bill is largely neutral with a slight positive score due to its alignment with the Ninth Commandment. However, greater accountability to biblical principles and ensuring funds do not contribute to excessive taxation or waste could strengthen its alignment with God's law.

A zero score is 50% of what it could be, therefore is still an F grade.

An acceptable score in 2025 needs to be a slight positive of 60%

(Understanding that it takes time to improve, minimum values increase over next few years.)
